("DuPont") held by the Reporting Person, and the Reporting Person's equity awards denominated in DuPont common stock were adjusted, in part, into equity awards denominated in Qnity common stock, all as described in Qnity's information statement filed as Exhibit 99.1 to the Current Report on Form 8-K that was filed by Qnity with the Securities and Exchange Commission on October 15, 2025, in connection with the spin-off of Qnity from DuPont. This amount includes restricted stock units and dividend equivalent units.

2. Represents equity awards originally granted by DuPont de Nemours, Inc. ("DuPont") that have been converted into Qnity equity awards in connection with the spin-off of Qnity from DuPont.
